Please do not ignore this communication, access to Wokingham Cricket Club Teamapp is dependent on your response.

The General Data Protection Regulation (EU) 2016/679 (GDPR) is a EU regulation on personal data protection and privacy. GDPR achieves the uniformity in the data protection rules applicable to all individuals within the European Union.

In accordance with GDPR's requirements, we kindly ask you to give us your consent to the collection and processing of some of your personal data by Wokingham Cricket Club in the conditions described below. Juniors under 18 years of age need a parent or guardian to give their consent. The collected personal data will solely be used for membership enrolment, relevant cricket organisations, sending you our announcements and newsletters as well as for sending you invitations to events organised or sponsored by Wokingham Cricket Club. In addition, by giving your consent, you agree not to share any information that you have access to, by whatever medium to any third party without the express written permission of Wokingham Cricket Club. Sharing such information will result in your suspension from all Wokingham Cricket Club accessible forums. If we have not received your consent before 25th May 2018, we will no longer be authorised to send you any communication or invitation.

In the context of dissemination of communications and invitations by Wokingham Cricket Club, your personal data will be collected and processed as follows:

**1. Personal data collected by Wokingham Cricket Club**

Wokingham Cricket Club will solely collect your name, first name, address, date of birth, email address, school if applicable, information for payroll purposes if applicable, relevant medical information and phone number(s).

**2. Processing of your personal data by Wokingham Cricket Club**

Wokingham Cricket Club will process your personal data for the sole purpose of sending you communications and/or invitations, information regarding any cricketing activity including membership, in person or online and payroll if applicable. Your data will also be used and transmitted to affiliated leagues including Play Cricket for cricketing purposes. Further use of your personal data, out of that context, will require another specific consent.

Wokingham Cricket Club is dedicated to deal with and process your personal data with due care, in confidence and in accordance with the applicable data protection laws and with the

### 3. Storage of your personal data

Wokingham Cricket Club takes reasonable and appropriate technical and organizational security measures in order to (i) store your personal data in secure databases or systems with restricted access and (ii) protect them against loss, accidental or intentional misuse, alteration, destruction and access by unauthorized persons.

Please kindly note that some of the databases or systems used by Wokingham Cricket Club for mailing services and storage systems may be hosted and/or maintained by third party service providers located inside or outside of the European Union.

Your personal data will be only disclosed to such service suppliers if Wokingham Cricket Club has deemed, in its reasonable opinion, that such service providers offer appropriate guarantees with regard to confidentiality, security and protection of your personal data.

### 4. Your right to access, correct and request the deletion of your personal data

You have the right to access, modify, correct and/or request the deletion of your personal data at any time as well as to restrict or oppose to the use of your personal data for the purposes mentioned above. All data will be deleted within 3 months of the first league match if you have not renewed your membership, other than data required to be kept for government agencies.

You may also withdraw your consent to receive communications or invitations at any time by sending an email to [privacy@wokinghamcricketclub.co.uk](mailto:privacy@wokinghamcricketclub.co.uk) or by clicking the unsubscribe link in the footer of any invitation or communication sent by Wokingham Cricket Club. In that case, Wokingham Cricket Club will immediately cease to send you communications and invitations, including any cricket related matters.
